#### 1.4.2 SPECIFICATIONS

#### **Utilization of assets**

The foundation's financial resources are used to support and achieve the Foundation's objective.

The NGO Friends of the Port Reitz School carries out our program for which we generate the funds.

The main expenses of the NGO are:
School fees, school uniforms & school necessities
Medical aids, students' transport, food & water
Salaries staff Port Reitz School
Projects
Administration costs

#### **Salaries**

The foundation itself has no staff and works exclusively with volunteers. The mentioned salaries relate to local staff, such as teachers, cooks, housemothers, house-fathers physiotherapists, orthopaedic technicians, agricultural specialist and trainees working at the Port Reitz School in Mombasa, Kenya.



Also Kenya was hit by the Covid-19 pandemic and went into lockdown. The government had sent all the staff paid by the government, on unpaid leave. Despite the fact that the Port Reitz School is a boarding school and that the Shamba (agricultural) project had to continue. Therefore the foundation decided to step in and supported the staff on unpaid leave, financially.

### Shamba project

In 2020, Kenya was not only hit by Covid-19 pandemic, but also suffered from 2 locusts plagues and currently a third generation is on its way. A disaster for the country.

The situation before the locust plague in Kenya;

- 1 in 3 people had to deal with food insecurity and poor nutrition
- 26% of children under the age of 5 were chronically malnourished, resulting in both cognitive and physical growth inhibition.

And that in a country where 75% of the people depend on agriculture. It is 33% of GDP.

But besides the locust plagues the lock-down from major cities caused lots of problems. There was no storage capacity for the food available which resulted that 40% of the little harvest the country had, got lost.

In order to generate a more balanced diet for the children, we had no other choice then to expend the Shamba and to protect the crops with shade nets.

#### Administration and fundraising costs

In 2020, € 3,243 (2.78%) of the total expenditure for the financial year was spent on fundraising, bank and administration costs to enable the foundation to run. Divided as follow

Fundraising € 2,711
Bank costs € 489
Administration costs € 43

The foundation received € 2,711 in specific donations for the purpose of fundraising.

The telephone costs, averaging € 100 per month are carried by the board members privately and are therefore not included in the overview.

# Cost of travel and lodging

Our main sponsor "Stichting 't Groenland from The Netherlands, supports our foundation with € 54,800 per year. It is essential for Stichting 't Groenland that the board members of our foundation visit the Port Reitz School on a regularly basis to ensure proper use of their donations. The € 54,800 therefore includes an amount of max. € 6,716 per year that must be spent on travel and lodging expenses. Due to the Covid-19 pandemic and 2 generation of locust plagues, 2020 has been in many ways a very challenging year. It even had an effect on the travel expenses which resulted in total expenditure of € 9,106. According to

our guidelines, the difference of € 2,390 has been donated to the foundation mentioning specific donation.
